

TSA PRECHECK APPLICATION

Designated low risk travelers on domestic and international flights can **fast track security** at participating US airports. This means that low risk travelers who join the TSA Precheck program no longer need to stand in line waiting for security checks and **do not need to remove items of clothing or show laptops and liquid bags**. (TSA may still add random security checks)

HOW TO APPLY

1. Pay the IVT service fee via PayPal **Please note: We cannot use your credit card to pay for the IVT service fee**
2. Fill out this application form and save as a separate file on your desktop ready to email **OR** print off this application form and fill out by hand in clear bold capitals.

ATTENTION! THERE ARE TWO FEES PAYABLE FOR PRECHECK WHEN USING IVT:

1. IVT service fee (\$129.99) paid through PayPal for application review, checks, processing and monitoring.
2. Transportation Security Administration fee (\$85) paid at the interview. This fee covers background and law enforcement checks.

WHAT HAPPENS NEXT?

1. IVT carefully check your data, email you regarding any omissions and submit your information and pay the government fees for your background and security checks.
2. IVT arrange your compulsory interview at your preferred location and send you details regarding this and the documentation you need to take with you.
3. You attend the interview, show your documentation and if approved to the program TSA will send you your Known Traveler Number (KTN) by mail.
4. Every time you book a flight ticket you must enter your Known Traveler Number (KTN) so that you can use the Pre-check lanes
